

„Maxton Merch” Promotion Terms and Conditions

§1. Definitions

1. The terms used in these regulations (hereinafter referred to as the "Regulations") mean:

- a) "Campaign Home Page" - the website located at: www.maxtondesign.com;
- b) "Organizer" - the organizer of the Promotion, i.e. Maxton Design Piotr Kardaś with its registered office in Wojnicz, ul. Podlesie 26, 32-830 Wojnicz, Poland;
- c) "Promotion" - the "Maxton Merch" promotion conducted under the terms and conditions specified in the Regulations, which can be found in the Promotion Regulations tab on the campaign home page;
- d) "Participant" - a natural person, of full legal capacity, taking part in the Promotion and a legal person, as well as an organizational unit to which the regulations grant legal capacity.

§2. General provisions

1. The Promotion is conducted by the Organizer from 03.04.2025, 00:00 (UTC +01:00) until the stocks of products from the Merch category are exhausted, exclusively through the campaign home page.
2. The Promotion covers orders placed in the Organizer's online store, the value of which exceeds € 100 / PLN 418 net. The amount of shipping costs is not included in the amount necessary to participate in the Promotion.

§3. The aim of the promotion

1. The aim of the Promotion is to sell products from the Merch category for customers placing orders in the Organizer's online store in accordance with the Regulations, which can be found in the Promotion Regulations tab on the Campaign website.

§4. Terms and conditions of participation in the promotion for the individual customers

1. Participation in the Promotion is voluntary.
2. The condition for participation in the Promotion is to accept the Regulations and purchase products for an amount of at least € 100 / PLN 418 net.
3. By placing an order, the participant in the promotion accepts the Promotion Regulations, which can be found in the Promotion Regulations tab on the Campaign website.

4. As part of the Promotion, the individual customer will receive from the Organizer the opportunity to purchase products from the "Merch" category at a price of € 1 / PLN 4.34 net per item for € 100 / PLN 418 net in the amount of the order in the Organizer's online store.

- a) The condition for receiving products from the "Merch" category at a promotional price is to place an order for an amount of at least € 100 / PLN 418 net;
- b) The price of products from the "Merch" category purchased as part of the promotion does not include shipping costs;
- c) A product from the "Merch" category will be selected by the Organizer and delivered to the individual customer along with the order placed during the Promotion;
- d) By placing an order between 03.04.2025, 00:00 (UTC +01:00) and the end of the Promotion, the individual customer accepts the Promotion Regulations, which can be found in the Promotion Regulations tab on the Campaign home page.
- e) The Promotion for individual customers is valid from 03.04.2025, 00:00 (UTC +01:00) while stocks last.

§5. Terms and conditions of participation in the promotion for wholesale customers/dealers

1. In order to participate in the Promotion, the wholesale customer/dealer must agree to the terms of the Promotion contained in these Regulations.

2. The wholesale customer/dealer may place an order covered by the Promotion with the Organizer from 3.04.2025, 00:00 (UTC +01:00).

3. As part of the Promotion, the wholesale customer/dealer will receive from the Organizer the opportunity to purchase products from the "Merch" category at a price of € 1 / PLN 4.34 net for € 100 / PLN 418 net net in the amount of orders in the Organizer's online store.

- a) The condition for receiving products from the "Merch" category at a promotional price is to place an order for a minimum amount of € 100 / PLN 418 net net;
- b) The price of products from the "Merch" category purchased as part of the promotion does not include shipping costs;
- c) A product from the "Merch" category will be selected by the Organizer and delivered to the wholesale customer/dealer along with the order placed during the Promotion;
- d) By placing an order between 3.04.2025, 00:00 (UTC +01:00) and the end of the Promotion, the wholesale customer accepts the Promotion Regulations, which can be found in the Promotion Regulations tab on the Campaign home page;
- e) The Promotion for wholesale customers/dealers is valid from 3.04.2025, 00:00 (UTC +01:00) while stocks last.

5. The wholesale customer/dealer's participation in the Promotion is subject to accepting these Promotion Regulations.

§6. Purchasing discounted products

1. In order to purchase a product offered for sale as part of the Promotion directly in the Organizer's online store, active at <https://www.maxtondesign.pl>, the following steps should be taken:

a) go to the website at <https://www.maxtondesign.com>;

b) place an order in accordance with the stages of the Organizer's online store, after selecting products, in the "Basket" tab, select consent to participate in the Promotion.

3. The sales agreement for the product covered by the Promotion is concluded at the time of effective placement of the order in the Organizer's online store operated at <https://maxtondesign.com>.

4. The Organizer may end the Promotion before the deadline for its official end if all products covered by the Promotion are sold out.

5. The moment of ending the order for a product covered by the Promotion is assessed according to the real time of execution by a given Participant. Any doubts regarding the timeliness of placing an order will be immediately resolved in favor of the Participant after analyzing the proof provided by him/her to confirm the time of placing the order.

6. Any disruptions, and in particular delays in the functioning of the telecommunications network, adversely affecting the placing of an order under the Promotion, will be resolved in favor of the Participant, in accordance with the circumstances of the disruption, and this applies only to orders effectively placed during the Promotion.

7. The Organizer is not responsible for errors and disruptions related to failures not directly related to the <https://maxtondesign.pl> website and not resulting from the Organizer's fault.

§7. Exclusion from participation in the promotion

1. The Organizer has the right to exclude a Participant with immediate effect from participation in the Promotion in the event of failure by the Participant to comply with the provisions of the Regulations, as well as in the event of receiving information about actions contrary to the provisions of the Regulations or the purpose and idea of the Promotion.

2. Actions contrary to the provisions of the Regulations or the purpose and idea of the Promotion are in particular actions aimed at or resulting in the purchase of products covered by the Promotion:

a) in a manner other than indicated in §6 of the Regulations;

- b) by exploiting errors in the operation of the Promotion system, its website or the Mobile Application;
- c) for a purpose other than indicated in these Regulations, the Regulations of the Organizer's store or other guidelines regarding the purchase of products via the Internet.

§8. Procedures for submitting and considering complaints regarding the promotion

1. Complaints regarding the course of the promotion should be submitted in writing to the following e-mail address:
 - a) individual customers: sales@maxtondesign.eu;
 - b) wholesale customer/dealer: info@maxtondesign.eu.
2. The participant has the right to submit a complaint regarding the mechanism and method of operating the promotion within no more than 5 calendar days from the date of the event.
3. The complaint should contain the name, surname, exact address of the participant submitting the complaint, as well as a detailed description and indication of the reasons for the complaint, indicating the date of the event that the complaint concerns. Messages that do not meet these criteria will be automatically rejected.
4. Complaints will be considered within 14 working days from the date of receiving the complaint by the organizer.

§9. Final provisions

1. The Regulations are available on the website and at the Organizer's registered office.
2. The Regulations are effective from 3.04.2025, 00:00 (UTC +01:00).
3. In matters not regulated by the Regulations, the generally applicable provisions of Polish law, the Sales Regulations / General Terms and Conditions of Sale for distance contracts shall apply. They are available at: <https://maxtondesign.com/eng-terms.html>.
