

# **Terms and Conditions „Carbon Promo” 2023**

## **§1. Definitions**

The terms used in these regulations (hereinafter: "Terms and conditions") shall mean:

1. "Campaign Home Page" - the website available at: [www.maxtondesign.pl](http://www.maxtondesign.pl);
2. "Organizer" - the organizer of the Promotion, i.e. Maxton Design Piotr Kardaś based in Wojnicz, 26 Podlesie Street, 32-830 Wojnicz;
3. "Promotion" - "Carbon Promo" conducted under the terms of the terms and conditions, which can be found in the "Promotion Regulations" tab on the main page of the campaign;
4. "Participant" - natural person, of full legal age, with full legal capacity, participating in the Promotion, as well as a legal person, and an organizational unit to which legal capacity is granted by law;

## **§2. General provisions**

1. The Promotion is conducted by the Organizer from 1.07.2023r, 00:00 (UTC +01:00) to 31.07.2023r, 23:59 (UTC +01:00), exclusively through the Campaign homepage. The Organizer has the right to terminate the Promotion earlier, of which the Participants will be notified via an announcement on the Campaign homepage.
2. The amount of the granted discount for individual customers is determined by the Organizer and is 10% off the regular price.
3. The amount of discount granted for wholesale customers/dealers is determined by the Organizer. Information about the amount of the discount and the rules for participation in the promotion will be provided to each wholesale customer/dealer by e-mail.
4. The promotion applies only to products offered by the Organizer, made of carbon fibre. Other products from the Organizer's offer are not included in the promotion.
5. The "Carbon Promo" promotion shall not be combined with other promotions.

### **§3. Aim of the promotion**

1. The promotion aims to provide its Participants with an opportunity to purchase a given product offered in the Organizer's online store at discounted prices obtained by using a discount code, in accordance with the content of the Regulations, which can be found in the "Promotion Regulations" tab on the Campaign website.

### **§4. Conditions for participation in the promotion**

1. Participation in the Promotion is voluntary.

2. To participate in the Promotion, the participant must accept the Terms and Conditions, perform the activity specified below and make a purchase of a product covered by the Promotion. By placing an order, the Promotion participant accepts the Promotion Terms and Conditions, which can be found in the "Promotion Regulations" tab on the Campaign website.

### **§5. Terms of participation in the promotion for wholesale customers/dealers**

1. Participation of the wholesale customer/dealer in the Promotion is voluntary.

2. A wholesale customer/dealer may place an order with the Organizer within the period from 1.07.2023r 00:00 (UTC +01:00) to 2.08.2023r 23:59 (UTC +01:00). Orders placed before and after the specified date will not be included in the Promotion.

3. Participation of the wholesale customer/dealer in the Promotion is subject to the following conditions:

- a) acceptance of these Terms and Conditions;
- b) in the case of running a campaign on their own, creating their own version of the terms and conditions of the "Carbon Promo" in accordance with the laws of the country in which the dealer runs the campaign;
- c) sharing the promotional graphics provided by the Organizer or made in-house on the social media profiles run by them.

4. Failure to meet the above conditions shall result in the wholesale customer/dealer not being included in the Promotion.

5. The Organizer reserves the right to verify the activities performed by the wholesale customer/dealer related to the Promotion, including:

- a) verification of compliance with the activities required by provisions of these terms and conditions;
- b) verification of the manner of sales of the promotional products;
- c) verification of the time at which the order of the wholesale customer/dealer was placed.

### **§6. Purchase of the products included in the promotion**

1. To purchase a product offered for sale under the Promotion directly from the Organizer's online store, active at <https://www.maxtondesign.pl>, take the following steps:

- a) visit the website at <https://www.maxtondesign.pl>;
- b) place an order in accordance with the steps of the Organizer's online store, after selecting the products, in the "Cart" tab, enter the received discount code in the designated field, and then apply the code by clicking the "Confirm the Code" button.

2. The conclusion of the sales agreement for a product included in the Promotion occurs at the moment of effective order placement in the Organizer's online store operating at <https://maxtondesign.pl>.

3. The Organizer may terminate the Promotion before the official termination date if all products included in the Promotion are sold out. The Organizer shall inform the customers about the earlier termination of the Promotion through a relevant notice on the Organizer's website.

4. The moment of completion of an order for a product included in the Promotion shall be judged according to the real time of execution by a given Participant. In the event that the order information is received by the Organizer after the date of 31.07.2023 23:59:59 (UTC +01:00), while the Participant attempted to order in a timely manner, any doubts regarding the timeliness of the order shall be immediately considered in favour of the Participant after reviewing the proof provided by the Participant to confirm the time of the order.

5. Any disruptions, in particular delays in the operation of the ICT network, adversely affecting the placement of an order under the Promotion, shall be considered in favour of the Participant,

according to the circumstances of the resulting disruption, and this shall only apply to orders successfully placed during the Promotion.

6. The Organizer shall not be responsible for errors and disruptions related to failures not directly related to the <https://maxtondesign.pl> website and not attributable to the Organizer.

### **§7. Exclusion from participation in the promotion**

1. The Organizer reserves the right to exclude the Participant with immediate effect from participation in the Promotion in the case of non-fulfilment by the Participant of the provisions of these Terms and Conditions, as well as in the case of becoming aware of any act contrary to the provisions of these Terms and Conditions or the purpose and idea of the Promotion.

2. Acts inconsistent with the provisions of the terms and conditions or the purpose and idea of the Promotion are, in particular, actions aimed at or resulting in the purchase of products included in the Promotion:

a) in a manner other than indicated in §6 of the terms and conditions;

b) by taking advantage of errors in the operation of the Promotion system, its website or Mobile Application.

### **§8. Mode of submission and consideration of complaints regarding the Promotion**

1. Complaints regarding the conduct of the Promotion shall be submitted in writing to the following e-mail address:

2. The Participant has the right to submit a complaint regarding the mechanism and operation of the Promotion within a maximum period of 5 days from the date of the event's occurrence.

3. The complaint should contain the name, surname, exact address of the Participant submitting the complaint, as well as a detailed description and indication of the reason for the complaint, with an indication of the date of the event referred to in the complaint. Messages that do not meet these criteria will be automatically rejected.

4. Complaints will be considered within 14 working days from the date of receiving the complaint by the Organizer.

### **§9. Final provisions**

1. The Terms and Conditions are available on the website and at the registered office of the Organizer.

2. These Terms and Conditions are valid from 1.07.2023r 00:00 (UTC +01:00) to 2.08.2023r 23:59 (UTC +01:00).

3. In matters not regulated by these Terms and Conditions, the generally applicable provisions of Polish law, the Terms and Conditions of Sale/General Terms and Conditions of Sale for distance contracts (available at <https://maxtondesign.pl/pol-terms.html>) shall apply.
